## WAIVER OF CLAIMS AND ASSUMPTION OF RISK AGREEMENT

I fully understand that all activities at Reid Ranch including, but not limited to, horseback riding, mountain biking, boating, swimming, archery, hiking, and all other athletic and non-athletic activities can be dangerous. I know that there is a possibility that I or my child or ward could be injured or killed. I hereby voluntarily assume any and all risks, including injury to my person or my child or ward and property, now or in the future, which may be caused as a result of participating in these activities, riding these animals or that may be caused by the actions or negligence of REID RANCH, its employees, and guests.

In consideration for permission to participate in said activities, including, but not limited to, horseback riding, mountain biking, boating, swimming, archery, hiking, and all other athletic and non-athletic activities, I hereby voluntarily release, waive, and discharge REID RANCH from any and all claims, demands, and causes of action of any nature whatsoever which I, or my spouse, family assigns, or successors may have against any of them, for, on account of, or by reason of my assumption of this risk.

I acknowledge and represent that neither I nor my child or ward am/is suffering from any physical impairment which would affect my ability to participate in any activities, including, but not limited to, horseback riding, mountain biking, boating, swimming, archery, hiking, and any and all other athletic and non-athletic activities. Neither I nor my child or ward am/is suffering from any physical impairment which makes it more likely that my child, my ward or I may be injured by riding horses.

There are inherent risks associated with participation in any livestock or equine activities. "Inherent risk" with regard to equine or livestock activities means those dangers or conditions which are an integral part of equine or livestock activities, which may include:

- (a) the propensity of the animal to behave in ways that may result in injury, harm, or death to persons on or around them;
- (b) the unpredictability of the animal's reaction to outside stimulation such as sounds, sudden movement, and unfamiliar objects, persons, or other animals;
- (c) collisions with other animals or objects; or
- (d) the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within his or her ability.

The sponsor, Reid Ranch, LLC, is not liable for any of these inherent risks.

I hereby grant Reid Ranch the right to photograph and/or videotape me or my child or ward and to display or use these photograph(s) and/or videotape(s) in any or all types of media and/or paper mediums whether for advertising, publicity and/or promotional purposes.

- No horseback rider may exceed 250 lbs.
- Helmets and vests are required for all horseback riders, whether experienced or not.
- Helmets are required for mountain biking.
- Life jackets are required in our lake area.
